




#### **Chevron Net Income** 1Q08 vs. 4Q07




# U.S. Upstream Income 1008 vs. 4007



### International Upstream Income 1008 vs. 4007




### Worldwide Oil & Gas Production<sup>(1)</sup> 1Q08 vs. 4Q07




### U.S. Downstream Income 1008 vs. 4007




# International Downstream Income 1008 vs. 4007
